1. This show will be governed by the latest ARBA Rules.
2. NO SMOKING IN THE SHOWROOM.
3. The WBRC reserves the right to substitute or add judges.
4. Classes will be announced TWO times only. Individual animals and/or exhibitors will not be called.
5. All entries must be entered in the regular breed classes to be entered in fur.
6. All entries are final. Entries that are "scratched" will not be given a refund.
7. All rabbits must be permanently earmarked, cavsies must be tagged.
8. No awards will be mailed.
9. Only rabbits and cavsies will be allowed in the showroom. No other animals, except service animals allowed.
10. Animals found to be unhealthy, will be removed from the showroom and the entry fee forfeited.
11. Show officials are solely responsible for interpreting rules and dealing with problems arising during the show.
12. Show officials may refuse to accept any entry as they see fit.
13. NO unauthorized persons behind the show tables.
14. Solid drop pans with absorbent material will be required on all carriers.
15. WBRC is not responsible for unawarded sweepstakes.
16. WBRC AND THE MCLEOD COUNTY FAIRGROUNDS WILL NOT BE HELD RESPONSIBLE for losses in the event of fire, theft, or vandalism. Every precaution will be taken to prevent loss or injury.

**ARBA members, judges, registrars, transporters, and vendors residing in or traveling by motor vehicle through an area of the country that is part of an active RHD outbreak are discouraged from attending ARBA sanctioned shows in other areas or having contact with other rabbit breeders for 30 days of the last RHD confirmed positive case. Clubs are encouraged to acknowledge the potential need to cancel contracts due to RHD concerns when soliciting contractors to officiate or vend at ARBA sanctioned shows.**

**Owners who have experienced RHD infections in their herd are required to report the infection to ARBA and are ineligible to participate in and are discouraged from attending any ARBA sanctioned show/event for a period of 4 months from the last RHD-related death. These owners are strongly encouraged to avoid direct contact with other rabbit breeders / owners during this 4-month period.**

**ARBA sanctioned cavy-only specialty shows may be held provided the club's show rules contain a specific prohibition against rabbits being on the premises of the show site during the sanctioned show. The club must also provide the following awareness in their official show catalog: "Attendees must be aware that although RHD does not infect cavsies, the virus may be transmitted even without direct contact with rabbits. Many cavy breeders also raise rabbits; therefore, robust biosecurity measures must be taken to reduce the risk of transmission of this deadly virus." Judges residing in or traveling by motor vehicle through states with active RHD outbreaks are discouraged from officiating, although the ARBA recognizes the contractual agreements are made with the club hosting the show.**
